

FDA Says CVS, Walgreens Can Sell Abortion Pills

This is even worse than I anticipated. We've known that women can receive abortion pills via telemedicine (a hangover from the Covid exception) without ever seeing a medical professional and without an ultrasound. This puts a woman in significant danger of hemorrhaging due to a potential ectopic pregnancy or too late gestational age. I've long feared and spoken about a 16-year-old receiving abortion pills in the mail, ingesting them in her bedroom, then hemorrhaging in the bathroom without her parents knowing.

Now the FDA has decided that it is permissible for pharmacies (CVS and Walgreens are the first to indicate their intent to do so) to dispense the abortion pill by prescription. With extreme pro-abortion Josh Shapiro as Governor, what is to prevent it happening at our local CVS or Walgreens? Does this eliminate even the pretense of adhering to the PA Abortion Control Act's requirement for an initial counseling appointment (where pictures of babies at various gestational ages are shown and options are discussed) before an abortion? Does it remove the requirement for parental consent?

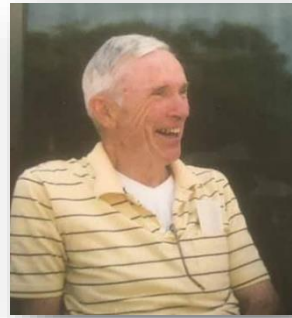

Mark, his wife, Ryan-Marie and their seven children live in Kintnersville Bucks County and are Parishioners at St. Agnes Church in Sellersville. Mark stands trial on January 24, 2023 in federal district court on brazenly false charges as part of President Biden's Department of Justice (DOJ)'s ongoing campaign to punish and intimidate pro-life activists.

With the FBI Raid at my home on September 23, 2022, all of my pro-life efforts have culminated into one defining moment. Who am I as a Catholic? Who am I as a father? Who am I as a husband? Who am I as a pro-life leader and activist? Who am I as an evangelist? I realize at this moment in time, God has called me to give witness to all of the identities that make me who I am. Finally as I wait to see the fruits of my recent labor which has drawn so much attention, I ask you to pray with me. Pray for God's holy will to be done in the lives of the judge, the Honorable Gerald Pappert, presiding over my case; Pray for the many abortion workers who have facilitated and corroborated this injustice to me and my family; Pray for my legal team made up of Brian McMonagle and Peter Breen, from the Thomas More Society; And finally, pray for the twelve jurors who will decide my fate.

And Justice for All?

Since *Roe v. Wade* was overturned on June 24, 2022, more than 200 pro-life pregnancy centers and churches have been vandalized and the Department of Justice has prosecuted no one. They have, however, charged at least 22 pro-life individuals (Mark Houck & others) for violating the Freedom of Access to Clinics Act. On January 11, 2023 the U.S. House voted 222-208 on a measure to condemn attacks on these pro-life centers and churches. Please pray for the 208 Democrats who voted to allow this violence to continue.
