We found out earlier this year, during a 20 week Ultrasound, that our second child had anencephaly. Our doctor explained this condition and recommended abortion. We clearly told the doctor that abortion was not an option. We would like to carry our baby girl to full term and giving her a fighting chance. Prayer requests were sent out and we spent time at the Precious Blood Monastery in NY. We prayed in front of the abortion clinic, and spent time with our spiritual director, and the cloistered sisters. We chose to spend the rest of our pregnancy joyfully living each day loving Lily, sharing our love and life with her. On August 1, our daughter Lily was born and was immediately baptized. Lily was quiet, didn't utter a cry. Her eyes half open, lips open, as if she was trying to say something to us... We took turns holding Lily in our arms, kissing her, loving her, telling her how much we love her. Lily lived until 6:28pm when we knew Our Good Lord took Lily home, the Eternal Home we all long for. When couples are told of child's fatal condition, they are told that abortion is the better choice, the right choice to make. But in reality, families deserve to celebrate their child's life,



even if it is just for a short time. In choosing life, couples embrace the suffering, and face their fears. Choosing Life for Lily gave us hope, love, acceptance and joy. Abortion denies life and buries feelings. It sentences women and families to years of regret and suffering. It is the ultimate act of despair. But, our Lily Gianna was given a chance at life. However, pro-life groups received great news in July from Beth Duffy, CEO of Einstein Medical Montco, who advised one of our Board Members that Einstein Medical Montco will not be performing elective abortions. When asked about the pre-natal clinic performing abortions, Ms. Duffy advised that the clinic is for pre-natal care, not abortions. This is great news, thank you Jesus!
